

## Sephora Welcome Back Giveaway Official Rules

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Overview:** There are five hundred twenty-one (521) Sephora retail stores (each a “Participating Sephora Store”) participating in this promotion. See Appendix A for complete list of Participating Sephora Stores.

**1. Eligibility:** Sephora Welcome Back Giveaway (the “Instant Win Game”) is open only to legal residents of the fifty (50) United States, the District of Columbia, Canada and Puerto Rico who are at least eighteen (18) years old at the time of entry who are members of the Beauty Insider Program. Becoming a member is free. Void where prohibited. Employees, officers, and representatives of Sephora USA, Inc. (“Sponsor”), its parent and affiliate companies, Merkle Inc. (“Administrator”), J.C. Penney Company, Inc., Sephora inside JCPenney stores, and any advertising and promotion agencies involved in the Instant Win Game, as well as the immediate family (spouse, parents, siblings, and children and their respective spouses, regardless of where they reside) and household members of each such individual, whether or not related, are not eligible. The Instant Win Game is subject to all applicable federal, state, provincial, territorial, municipal, and local laws and regulations. Participation in the Instant Win Game constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Instant Win Game. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**2. Sponsor:** Sephora USA, Inc., 525 Market St., San Francisco, CA 94105, USA. **Administrator:** HelloWorld, Inc., 3000 Town Center, Suite 2100, Southfield, MI 48075, USA.

**3. Timing:** The Instant Win Game begins on August 14, 2020, when the applicable Participating Sephora Store opens, and ends on August 23, 2020, when the applicable Participating Sephora Store closes (each its “Applicable Promotion Period”, collectively the “Promotion Period”). *Store hours vary. Contact your local Sephora Store for specific store hours.* Administrator’s computer is the official time-keeping device for the Instant Win Game.

**4. How to Enter:** During the Promotion Period, visit your local Participating Sephora Store and use your smartphone or other web-enabled device with data plan to scan the Instant Win Game quick response (“QR”) code\* featured on signs and postcards in Sephora stores with the QR reader application already installed on your phone. You will be directed to a mobile web page associated with your Participating Sephora Store (“Website”). Or, to enter without using your smartphone or web-enabled device, visit the website URL directly, which will also be featured on signs or promotional materials, from your desktop computer. Then, follow the links and instructions to register for the Instant Win Game by providing the email address associated with your Beauty Insider account. If you are not a Beauty Insider member, you must become one in order to play the Instant Win Game. Once you submit the form, you will automatically proceed to the Instant Win Game page and receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Entrants will be notified immediately by email if they are potential winners of the Instant Win Game and will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

\*To scan a QR code, participants must have a smartphone or other web-enabled device with a camera feature and QR scanner application and may incur message or data charges from their wireless service provider for each message sent and received.

**Limit:** Each entrant may play one (1) time per day during the Promotion Period, regardless of method of game play. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant’s plays and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Released Parties (as defined below) are not responsible for lost, late, incomplete, invalid, unintelligible, garbled, inaccurate, or misdirected registrations, game plays, or prize claims, all of which will be

disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player, and such entrant or player must comply with these Official Rules. The “authorized account holder” is the natural person assigned an email address by an internet access provider, online service provider, internet service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

**6. Instant Win Prize Selection and Verification of Potential Winners:** Receiving a prize is contingent upon compliance with these Official Rules. Administrator is an independent judging organization whose decisions as to the administration and operation of the Instant Win Game and the selection of potential winners are final and binding in all matters related to the Instant Win Game. There will be twenty thousand seven hundred two (20,702) random, computer-generated winning times during the Promotion Period, as outlined in Section 7 below. If you are the first player to play the Instant Win Game at or after one of the randomly generated times, you will be a potential instant winner of the prize indicated. If winner is a Canadian resident, he/she/they will be required to correctly answer a time-limited skill-testing question without any assistance in order to be eligible to receive a prize. If any potential winner cannot be contacted, fails to provide any other requested information within the required time period (if applicable), fails to correctly answer the time-limited skill-testing question (if applicable), or if prize is returned as undeliverable, potential winner forfeits the prize.
